

CMTA Membership Guidelines

Your interest in CMTA membership is greatly appreciated. It is through the support of the membership that CMTA is able to protect and promote the marine industry.

Membership Categories

✓ **Full Member**

Any individual, firm, partnership, or corporation which has an office in Connecticut and receives 50% or more of its gross income from and is engaged primarily in the Marine Industries.

✓ **Associate Member**

Any individual, firm, partnership, or corporation which has an office or representative in Connecticut with a significant interest in the Marine Industries and/or provides services to the Marine Industries.

✓ **Affiliate Member**

Any entity engaged in the Marine Industries regardless of whether an office or representative is located in Connecticut and is not otherwise eligible for Full or Associate Membership.

Membership dues investment levels are established by the CMTA Board of Directors and are subject to review and adjustment at any time. All membership applications are subject to Board approval.

Full payment of the annual investment plus the initiation fee must accompany this application. If membership is continuous, the initiation fee is payable only once.
